**PLEASE TAKE NOTICE** that on August 15, 2019, Aqua New Jersey, Inc., Maxim Sewerage Division, (the “Company”) filed a Petition with the New Jersey Board of Public Utilities (“Board”) for approval to increase the current level of its Purchased Sewerage Treatment Adjustment Clause (“PSTAC”). Specifically, the Company is seeking authorization to adjust the level of its PSTAC based on a net under-recovery of wastewater treatment costs for 2018, as well to set prospective rates for 2020 to recover estimated wastewater treatment costs. Consequently, the Company is proposing to increase its monthly PSTAC Surcharge from \$26.77 to \$31.92, an increase of approximately \$5.15 per month or approximately 19.2% per month. The monthly PSTAC Surcharge provides no profit to the Company and is a pass-through of actual charges from the Ocean County Utilities Authority.

**IF APPROVED, A RESIDENTIAL CUSTOMER WILL SEE HIS/HER TOTAL MONTHLY BILL FOR WASTEWATER SERVICE INCREASE FROM APPROXIMATELY \$52.10 TO APPROXIMATELY \$57.25, AN INCREASE OF \$5.15 PER MONTH, OR APPROXIMATELY 9.88%.**
